Failure to meet the requirements will require that the Parent/Guardian pays the full \$8,750 tuition out of pocket. <sup>2</sup>Reimbursement amount subject to change by the IDoE.

Parents/Guardians are responsible for the amount of tuition set forth in this contract. It is agreed that the payments set forth in this contract will be made by the first Monday of every month according to the payment schedule selected above. If the Parent/Guardian does not complete the required steps to qualify for ESA by the deadlines established by the Iowa Department of Education, Parent/Guardian is responsible for the full \$8,750 tuition per student.

A \$30 fee will be applied to your account for any returned checks. If your payment is not made according to the agreed-upon schedule, you will be contacted via email or phone to collect the funds past due. If you fail to resolve the delinquent amount within 1 business day after contact, Calvary Christian Academy reserves the right to temporarily dismiss your student(s) until the account is made current. Unpaid accounts may be sent to a collection agency, Parents/Guardians agree to be held liable for any associated costs, including attorney's fees.

If a student withdraws voluntarily from CCA during the school year, tuition will be prorated for the time the student attended, and all outstanding balances must be paid within 30 days of the withdrawal date. All voluntary withdrawals must be made in writing to the Academy Director.

CCA reserves the right to dismiss any student (temporarily or permanently) if, in the opinion of the Academy Director, the interest of the student, the Academy or other students will be best served by such dismissal. In the event of any dismissal, the tuition obligations of the Parent/Guardian to make timely and complete payments are not diminished or altered in any way and tuition will not be prorated.
